

2007 NEW JERSEY BRED RULES 2007

In order to qualify for year-end non racing breeder awards presented by the Department of Agriculture and administered by the Equine Advisory Board, the following rules must be abided by:

1. It shall be mandatory to show at the **Annual All Breed Show September 22, 2007** to be eligible for NJ Bred Awards. Exception: 2 yr. Old Snaffle Bit Horses will be required to show only at the **NJQHHA Summer Circuit July 5-8, 2007**. Only points from these shows will count. There are **NO** 2 yr old Snaffle Bit classes held at the NJ Bred Show.
2. A horse must enter at least three different NJQHA approved shows under three different judges with at least two horses entered, shown and judged in each class to count for points to be awarded. A veterinary certificate will be required if a horse is unable to show. Certificate must be presented prior to the start of the show to the NJQHA representative.
3. A horse must meet the definition of a New Jersey Bred Horse which is:
 - a. Any foal dropped in the state of New Jersey, except for the foal of transient mares. A transient mare is any mare arriving in the state for the sole purpose of dropping a foal. The mare must reside in the state for at least 120 consecutive days including the day of foaling. Owner may be asked to submit proof of such residence to NJQHA.
 - b. The get of any stallion standing only in New Jersey during the breeding season of the year in which the foal was conceived.
 - c. Foals resulting from transported cooled semen from a stallion standing the full season in the state of New Jersey, providing parentage is authenticated and transported cooled semen is agreeable to AQHA.
4. Owner must be member of the NJQHA or NJQHHA to qualify for awards.
5. A photo copy of the AQHA papers must be included with all NJ Bred Nominations to show current owner.
6. NJQHA point system will be used to determine NJ Bred Champion & Reserve horses from date of nomination.
7. Champion & Reserve Award will be given in the following classes:
Weanling Mare, Weanling Stallion, Snaffle Bit Western Pleasure*; {*only the four NJQHHA shows count}
Yearling Mare, Stallion & Gelding; Two yr old Mare, Stallion & Gelding; Three yr old Mare, Stallion & Gelding;
Aged Mare, Stallion & Gelding; Junior & Senior Hunter under Saddle; Junior & Senior Western Pleasure.
Hunter Hack; Working Hunter; Trail.; Western Riding.
8. The champion will receive 60% and the reserve will receive 40% of the total money in each class.
9. All horses could be tested following the placement of each class at the NJ Bred Show or the NJQHHA Shows.
10. It shall be the responsibility of the individual to have proper NJQHA or NJQHHA membership, to nominate their horses and to make sure their points are recorded correctly throughout the year.

The money allotted by the NJ Dept of Agriculture to the Quarter Horse Division is based on the number of horses shown at the **All Breed Show, Saturday September 22, 2007** and the NJ Bred Futurity Class held at the **NJQHHA Summer Shows, July 5-8, 2007**.

Remember the more horses shown
the more money allotted to NJQHA members.
